## 3. Responsibilities of AIHE

- To ensure that students are prepared and available for scheduled industrial visits and placement processes.

## 4. Responsibilities of Vanesha Ayutech

- To design and deliver skill-building programs that are relevant and beneficial to the students.
- To arrange and conduct industrial visits in a manner that maximizes learning outcomes for the students.
- To evaluate and consider AIHE students for internships and employment based on their suitability and performance.

## 5. Confidentiality

Both Parties agree to maintain the confidentiality of any proprietary information shared during the collaboration and not to disclose such information to any third party without prior written consent.

## 6. Duration and Termination


