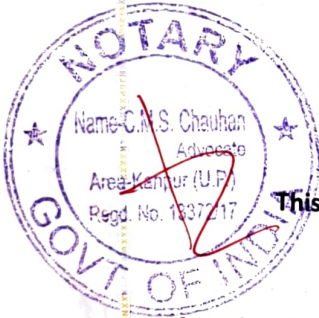

Be sure to get it so that in case of any inconvenience, you can register your complaint on the mobile number of the firm's complaint cell 8601003008/8601002999 by quoting your ID number. After paying the user charge, you must obtain the receipt from the firm, otherwise none of your statements regarding the above subject will be valid.

It is specially informed that the payment should be made only by matching your ID number with the receipt issued by the authorized representative of the company through the device through blue tooth printer. All commercial/institutions are requested to pay the company's bills only through cheque/draft or RTGS. Or do it through online transfer only and make payment only in the name of JTN Services Pvt. Ltd./Municipal Corporation Kanpur. Online Transfer / RTGS When payment is made through SBI, complete details of the payment to be made such as NEFT number/RTGS. Number or online transfer ID, date of payment etc. must be clearly provided to the firm's representation.

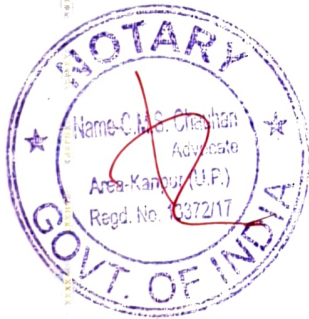

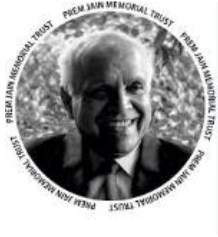

1.0 Preamble

Axis Institute of Higher Education, Kanpur, referred to as AIHE, located at Axis Knowledge City, Hathipur, Rooma, NH-2, Milestone-478, Kanpur-209402, Uttar Pradesh, India

This comes into effect from the date of signing of MOU

1.1 Prem Jain Memorial Trust

4.0 Govt. Representation & Use of Logos

- This MoU shall not be construed as creating a partnership, joint venture, principal agent, or any other relationship of any kind between Prem Jain Memorial Trust (PJMT) and Axis Institute of Higher Education (AIHE) and both are free to exercise judgment & discretion about the conduct of their respective businesses.

4.0 Tenure and Termination
