To ensure the secure and effective use of information technology resources, the Axis Institute of Higher Education hereby implements the Information Technology (IT) Policy effective from [22/06/2019].

The IT Policy is designed to provide guidelines for the appropriate use of the institution's IT resources, safeguard data, and maintain the integrity of the institute's information systems.

Key Points of the IT Policy

1. User Responsibilities

- All users must use IT resources responsibly and ethically.
- Users are required to maintain the confidentiality of passwords and other access credentials.
- Personal use of IT resources should be minimized and must not interfere with institutional operations.

2. Data Security

- Sensitive and confidential data must be protected and stored securely.
- Regular backups should be conducted to prevent data loss.
- Users must report any security breaches or suspicious activities immediately.

3. Software and Hardware Usage

- Only licensed software and authorized hardware should be used.
- Unauthorized installation of software or hardware is prohibited.
- IT support staff should be consulted before making any changes to the IT infrastructure.

4. Internet and Email Usage

- Internet access is provided for educational and professional purposes.
- Emails should be used in a professional manner and must not contain inappropriate content.
- Users must not engage in activities that compromise network security.
